The scientific component of the educational and scientific programme involves own scientific research by a PhD Candidate under the guidance of one or two scientific advisers and formalizing its results in the form of a dissertation. The scientific activity of postgraduate students corresponds to the line of research of scientific advisers.

The dissertation for a PhD degree is an independent detailed study that offers a solution to an urgent scientific problem in the field of social work, the results of which are characterized by scientific novelty and practical value, constitute an original contribution to the sum of knowledge of the relevant field and are published in relevant publications.

The scientific component of the educational and scientific programme is drawn up in the form of an individual plan of scientific work and provides for the following types of work:

- Scientific research and preparation of a dissertation.
- Approbation of the results of scientific research: publication of scientific papers (in accordance with current requirements), participation in scientific events (conferences, seminars, etc.), participation in research projects (including international ones).
- Certification: preliminary examination (defence of the dissertation).

The individual plan of scientific work is mandatory for a PhD Candidate and is used to assess the success of the planned scientific work.

Measures of assessment of the implementation of the scientific component of the educational and scientific programme:

- Report of PhD Candidates on the implementation of the individual plan of scientific work at the meetings of the Department of Social Pedagogy and Social Work.
- Preliminary examination (discussion) of scientific achievements in the form of a dissertation at a meeting of the Department of Social Pedagogy and Social Work.

The readiness of the dissertation for preliminary discussion is determined by the scientific adviser (or a consensus decision of two advisers).

A prerequisite for admission to the preliminary discussion is the successful completion by a PhD Candidate of his/her individual curriculum, individual plan of scientific work, and verification of the dissertation for text plagiarism (using Unicheck programme).



## **Areas of scientific research**

*Theory and methodology of social work:* philosophy and ethics of social work; categorical apparatus of social work; development of the theory of social work; models of social work practice; methods of studying social processes; history of social work; international social work.

*Practice of social work:* social assistance and social services to representatives of vulnerable groups, risk groups, and other subjects in a state of crisis, being subject to marginalization and social exclusion; social work in the system of socialization of a personality; development of a community and social partnership in the community; prevention of negative social phenomena; introduction of healthcare practices; counteraction to discrimination, stigmatization, and social exclusion on any grounds.

*Management of social work:* management of social work institutions; ensuring the quality of services in social work; development of supervision in social work; prevention of professional burnout of social workers; organization and optimization of volunteer activities; digitalization of social work, provision of social services by means of modern information technologies.

*Development of professional competencies of social workers:* topical issues of social education, career guidance and professional selection; professional development; optimization of vocational training programmes; provision and functioning of professional and ethical norms of social work.

*Complex problems in the field of social work:* theory and methodology of social work, practice of social work, professional competencies of social workers, teachers at higher education institutions).

*Interdisciplinary research on social work,* taking into account the sectoral context, historical and regional features, the experience of scientific schools of the university (inclusive education; youth work; gender socialization; socio-psychological features of the development of personality, social groups; social work in the community, etc.).

### **III. Form of Certification of Higher Education Seekers**

Certification of PhD Candidates is carried out in accordance with:

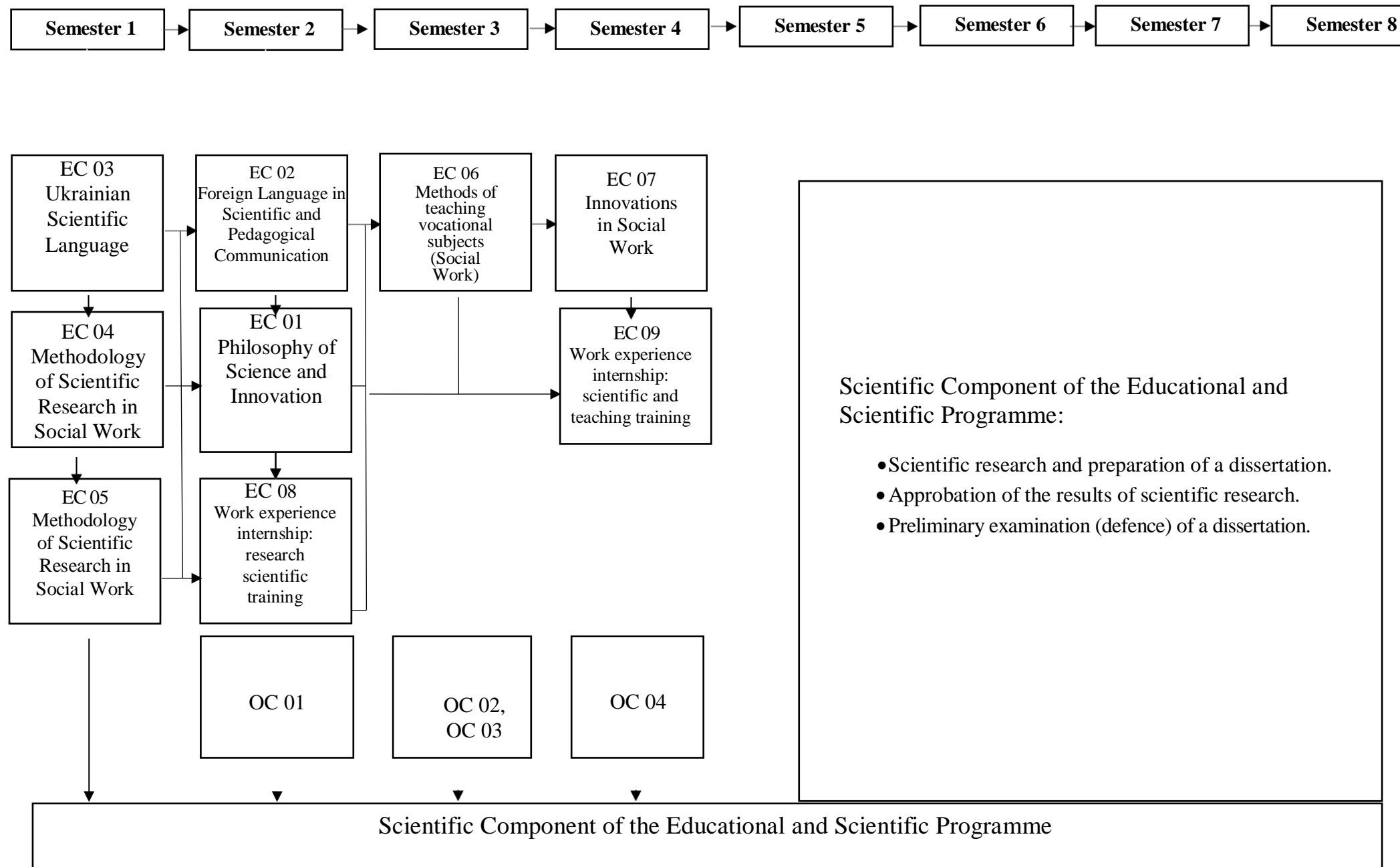

## **VIII. Requirements for the Availability of the System of Internal Higher Education Quality Assurance**

According to the Development Strategy of Pavlo Tychyna Uman State Pedagogical University for 2021–2025, one of the cross-cutting tasks is to ensure the quality of higher education. Pursuant to the requirements of national educational legislation, the procedures and measures for ensuring the quality of education at the University are regulated by the Regulation on Ensuring the Quality of Educational Activities and the Quality of Higher Education (2019) and the Regulation on the Participation of Students in Ensuring the Quality of Higher Education (2018), etc.

The system of internal quality assurance of educational and scientific activities of the University provides for:

- Control over personnel, material, technical, and methodological support of educational activities, the quality of educational classes, and the quality of knowledge of higher education seekers.
- Ensuring academic mobility of higher education seekers.
- Availability of information systems for effective management of the educational process.
- Monitoring and periodic review of educational programmes.
- Ensuring publicity of information about educational programmes, degrees of higher education, and qualifications.
- Prevention and detection of academic plagiarism in the scientific works of higher education seekers.

To ensure transparency and publicity of information about the University quality assurance system, ‘Quality of Education’ pages were created on the website of the University, the Faculty of Social and Psychological Education (<https://udpu.edu.ua/yakist-osvity/dokumenty#>; <https://is.gd/4DTqbM>), which contain continuously updated information on regulatory documents for regulating the internal quality assurance system, recommendations for maintaining academic integrity, results of monitoring studies, surveys, ratings of academic staff and structural units, information on the activities of the Employers’ Council, etc.

To ensure quality educational activities, for the functioning of the University system of informing, stimulating, and encouraging the quality of higher education, all educational process participants were involved. Each structural unit of the University directs its work to the constant updating of the syllabus, to improving of the mechanism of sufficient and high-quality resource provision of educational activities, the extensive employment of modern smart education information technologies, etc.

The organization of internal higher education quality assurance at the University as a whole and within the implementation of ‘Social Work’ ESP is carried out at the following levels: university, faculty, departmental, postgraduate, and teaching.

The University has created an educational environment in which seekers of the educational and scientific level of higher education are involved in the process of scientific research with the scientific adviser, fellow researchers having scientific interest in the related topics, and representatives of scientific schools.
